General Terms & conditions:

- (1) Material will be accepted subject to inspection of quality.
- (2) Allowed quantity variation ± 10% of the order or maximum one truck load whichever is less shall be acceptable.
- (3) For the increase in moisture rebate will be @ 1% per unit up to 11% moisture. Further deduction @ 2% per unit for the increase in moisture up to 13%. Goods are liable for rejection if moisture goes beyond 13%.
- (4) For increase in fiber rebate @ 1% per unit up to 12% of fiber. Goods above 12% fiber are liable for rejection.
- (5) For the increase in silica rebate @ 1% per unit up to 3.5% silica. Further deduction @2% per unit for the increase in silica from 3.5% to 5%. Goods are liable for rejection if silica is above 5%.
- (6) For decrease in crude protein per unit rebate will be @ 1.0% per unit below 35% up to 32% of crude protein and further deduction @ 2% per unit up to 30% of Crude protein. Goods found less than 30% Crude protein are liable for rejection.
- (7) Premium will be made @ 1% per unit, if sand silica content found in goods is less than 2.5%.
- (8) Old stock and material treated abnormally roasted/toasted are liable for outright rejection during physical inspection. Material over toasted i.e. over red or brown will be rejected.
- (9) Material should be fresh and free from moulds, fungi, rancidity, foul smell, lumps and castor husk, mahua cake and other adulterants including NPN/ Urea.
- (10) Moisture report of laboratory of CFP during receipt would be final and binding to the supplier.
- (11) Late delivery Penalty: The penalty will be imposed @1% of the total supply value for first 15 days and 2% up to 30 days after the due delivery date. The delivery of item beyond that needs further approval from Purchaser only.
